3. Monitor Findings including good practice and areas for improvement

The internal verification report of 3-5/12/14 notes that 100% check was completed, which is good practice. Some totting errors are identified however the commentary could be a little more expansive and note any issues arising and highlight good practice areas.

The external authentication report of 9/12/14 has completed a 50% sample. The strategy for sampling should be identified as it is unclear if this is the authenticators' own choice or centre policy. Comments could also be more comprehensive and highlight areas of good practice as well as identify any issues arising clearly.

The Results Approval minutes of 11/12/14 are fairly comprehensive. Learner numbers are specified in total and modules are listed but perhaps provider would include learner numbers per module delivered to facilitate reconciliation with returns to QQI.

Programme Validation

Provider has engaged in programme validation approval process for the programmes included in this results submission.

Website -

QQI has a new website and QQI award brand so the provider should familiarise themselves with this and ensure any links are correct. General care should be taken with award referencing to ensure the award code, award type and level on the NFQ are clearly set out on the provider's website. Use of 'FETAC' should be now phased out and replaced with the QQI award brand appropriately.
